Why did I want ISO9001?

- Precondition for some clients (e.g. public sector)
- Demonstrate commitment to quality
- Level playing ground with larger players
- Compete as a consultancy, not a contractor

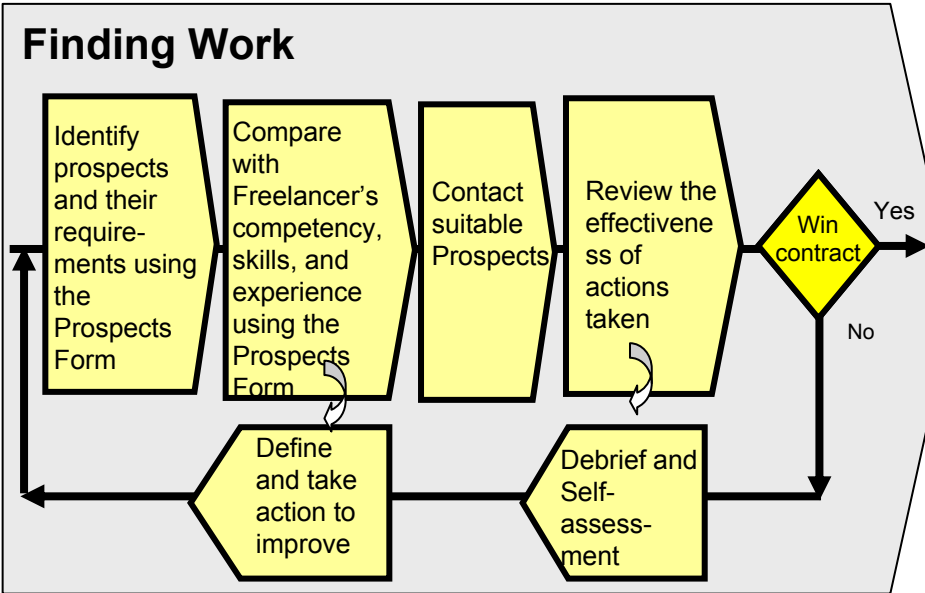

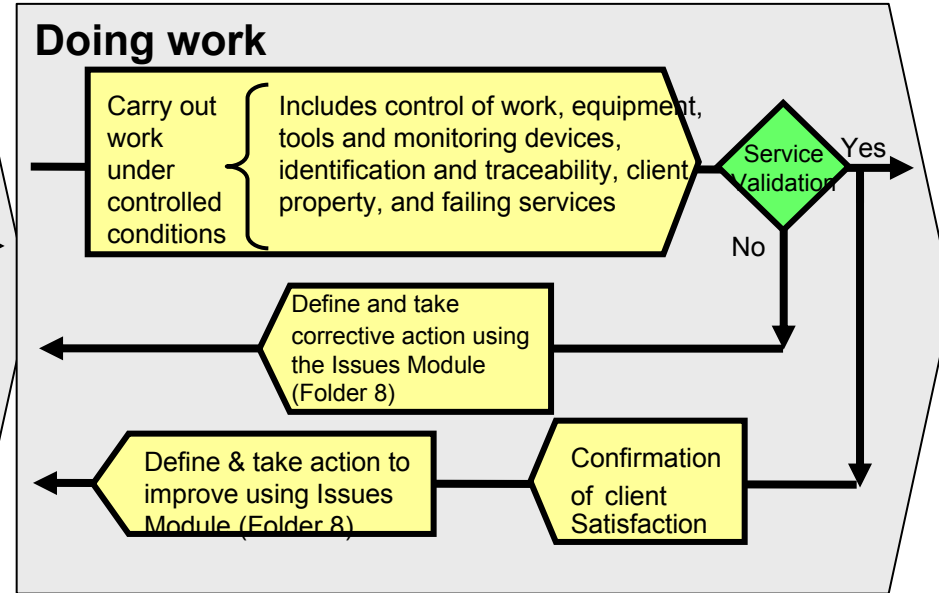

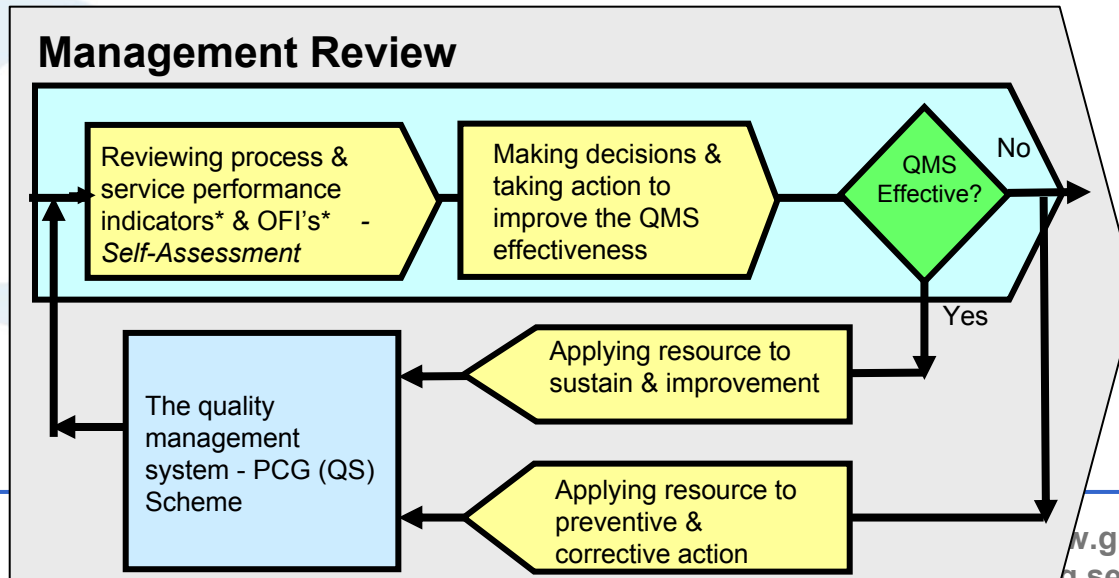

Central repository accessible for remote access by auditors

Local files synchronised with central repository (Subversion)

Costs

- Annual fee to PCG for hosting, audits, IPR
- Record keeping
 - Small overhead to things I'd do already (e.g. risk analysis)
 - Perhaps ½ hour to set up a new prospect / client
 - Perhaps ½ hour to set up a new subcontractor
 - Several weeks to set up QMS initially
- Management review and audit
 - Approx 1 day per quarter
 - Again, mostly time I should be spending anyway

Benefits

- Reminds me to do stuff I should be doing
 - Maintaining records
 - Risk analysis
 - Stepping outside day-to-day activities to review where I'm going
- Helps chase client feedback
 - Scope for improvement
 - Testimonials
- Helps people buy from me
- External checks are especially v
